Dear Sir,

We are now collecting suggestions for IEA activities in 1980 and thereafter for submission to the Executive Committee meeting on August 27 next when the future activities of the Association will be reviewed.

You will find in annex/a list of "subjects proposed for future activities", to be distributed with the Annual Report for 1977.

It would be useful for the work of the Executive Committee on August 27 if you could send to our Secretariat in advance any suggestions you may have as to possible subjects for conferences or other activities which might be fulfilled in future years. It is helpful if suggestions can be accompanied by a brief list of topics or outline indicating the aspects of the subjects which in your view should be discussed, with, if possible, suggested names of paperwriters.

Since the IEA is now obliged to seek considerable support from the host country in organising its conferences, an indication of whether there is a possibility of your country hosting one of our future conferences and, if so, the subject preferred, would be appreciated.

New suggestions which reach the Secretariat before August 23rd could probably be added to the list distributed for the consideration of the Executive Committee.

A provisional answer will also be welcome in the case that you do not feel able to be more specific at such short notice. Complementary information could be forwarded to the Members of the Executive Committee later, if you prefer.
